

## CPFI Mission Committee Report May 29, 2024

Praise the Lord short-term medical mission brigades through Global Health Outreach (GHO) continue.


- This past year 40 pharmacists and 15 pharmacy students participated in 34 trips that needed pharmacy coverage. There were 4 trips that went out without a pharmacist. This year so far in the first 4 months, 9 GHO teams have completed their outreach. One was a surgical team that did not require a pharmacist, 1 went without a pharmacist, 5 had one pharmacist, 1 team had 2 pharmacists and 1 had a pharmacist and a P4 pharmacy student.
- There are 13 teams going out in the next 3 months. Four of those trips have 2 or more pharmacists/students, 5 of them have 1 pharmacist and could use at least 1 more. Two trips have no pharmacists yet and could still use 2 or more and there were 2 surgical trips that do not require pharmacy services. These teams have 17 pharmacists and 2 pharmacy students.
- The remaining 16 teams scheduled this year have several openings. There are 6 pharmacists and 7 pharmacy students signed up. Two trips have two or more and are full, while two have 1 pharmacist and could use at least 1 more. One trip is a surgical trip and does not need pharmacy services and there are 11 that could use 2 or more pharmacists/students.


Thanks to the CPFI members who have participated this year: We look forward to pharmacists, student pharmacists, and other servants serving in the year to come.
